## About the Whistleblowing Legislation

Whistleblowing legislation was enacted in 2019 to provide greater structure and clarity to whistleblowing in an effort to ensure that leaders in workplaces affected by the legislation are responsible for the legal and ethical behaviour of their business and how to protect employees who are considered whistleblowers.

## Course Design

### Online Learning

The course is a self-paced online course which delivers the content over seven modules:

1. Introduction to Whistleblowing
2. Whistleblowing Legislation
3. Complying with Whistleblowing Legislation
4. What type of complaints attracts whistleblower protections?
5. Eligible recipients of complaints
6. Whistleblower Policy
7. Discussion

There are self-assessment quizzes to ensure your comprehension and a discussion question. We also provide a policy framework and detail about the main components of a Whistleblowing Policy. And, we also have access to an pre-recorded online video.
